

APPLICATION PROCEDURES FOR THE CULTURAL DIVERSITY TUITION WAIVER PROGRAM

Cultural Diversity Waivers are intended to encourage enrollment of a culturally diverse student body for the benefit of all students and the academic community.

Eligibility: (Applicant must meet one of the following definitions for eligibility)

- Enrolled members of federally recognized American Indian Tribes, and Alaska Natives and villages as defined pursuant to the Alaska Native Claims Settlement Act. Special emphasis will be given to enrolled members of the Spirit Lake Sioux Tribe, Three Affiliated Tribes, Turtle Mountain Band of Chippewa and Standing Rock Sioux Tribe and graduates of North Dakota Tribal Colleges.
- Members of a culturally diverse group, who are defined as historically underrepresented (African American, Asian American, American Indian, or Hispanic) persons of different cultural, racial, or ethnic heritage. International students do not qualify for this program.
- Students who have third party aid (tribal funding, Job Service, employer or other scholarships) above the cost of tuition, fees, books, housing, tools and supplies may be subject to denial of the waiver.
- Students who previously received the waiver and met the maximum eligibility requirements are not eligible to receive the waiver.

To Apply: Priority deadline for top consideration: May 1st - Fall semester or November 1st - Spring semester. Due to the limited number of awards available, not all applicants are guaranteed this waiver. Priority is given to students with high financial need based upon their FAFSA. If denied, students must reapply each year for consideration.

To be considered for the Cultural Diversity Tuition Waiver the following documents must be completed and submitted to Bismarck State College Financial Aid Office:

- Apply to Bismarck State College and be accepted as a degree seeking student for fall or spring semester.
- Free Application For Federal Student Aid (FAFSA) submitted with BSC's college code 02988, free of errors by March 1 of each aid year.
- Cultural Diversity Tuition Waiver Application by each semester deadline date. Students are encouraged to provide tribal enrollment verification or other related documentation to support ethnicity.

Academic Considerations:

Past academic performance will be used to determine initial eligibility. A student must meet at least one of the following criteria:

- Must not have earned a degree from an institution of higher learning.
- Currently enrolled Bismarck State College students who are not currently receiving the Cultural Diversity Waiver, minimum cumulative GPA of 2.00 with a 66.67% completion rate of all classes attempted and have earned less than 60 credits and in good academic standing.
- Currently enrolled high school student or high school graduate, ACT minimum composite score of 18 or high school GPA minimum 2.00.
- GED graduate, minimum average standard score of 500.
- Transfer students from a previous college, minimum cumulative GPA of 2.00 with a 66.67% completion rate of all classes attempted and have earned less than 60 credits and in good academic standing.

Amount of Waivers/Duration:

- **Waivers will not exceed 50% up to 15 credits of the Category 1 amount of tuition and are awarded to students taking on-campus classes only. Tuition waivers do not include application fees, technology fees, books, room and board, online classes or off campus programs.**
- **Recipients must be enrolled full-time at Bismarck State College.**
- **Awards will be issued for an academic year, which runs from August – May.**
