



Non-Credit Career Pathway Course
**CDL: HAZARDOUS
MATERIAL
ENDORSEMENT**



This course is three hours in length, delivered online, and meets the FMCSA requirements for Hazardous Material Endorsement Theory. Enroll anytime and complete the training within two weeks. Our CDL instructors and program manager will be available to answer questions by email and phone. Upon successful completion of all training modules and an 80% or better on assessments, students will be eligible to take the ND State Hazmat Knowledge Test at the ND Department of Transportation (ND DOT).

COURSE OUTCOMES:

Upon successful completion of the course, students will gain knowledge on: Basic Introductory and Operational HM Requirements; Reporting HM Crashes and Releases; Tunnels and Railroad Highway Grade Crossing Requirements; Loading and Unloading Hazardous Materials; HM on Passenger Vehicles; Bulk Packages; Operating Emergency Equipment; Emergency Response Procedures; Engine Fueling; Tire Check; Routes and Route Planning; and Hazardous Materials Safety Permits.

ND DOT TESTING REQUIREMENTS:

Class A Commercial Driver's License holders must complete the following requirements before scheduling the hazardous material knowledge test at the ND Department of Transportation (ND DOT): (1) Initiate the federal security threat assessment, this process can take 30-45 days; (2) Complete Hazardous Material Endorsement Training and pass the assessment with a score of at least 80 percent; (3) Complete practice tests on www.cristcdl.com/north-dakota/nd-cdl-practice-tests/; and (4) Schedule the hazardous material knowledge test at the ND DOT.
